## **GENERAL PROCUREMENT NOTICE (GPN)**

Version: 1.0 Publication date: July 4, 2024

The United States of America, acting through the Millennium Challenge Corporation ("MCC"), and the Government of Benin (the "Government"), signed on **December 14**, **2022** a grant agreement (« Compact ») to support regional economic integration. The Compact, covers an amount of **two hundred two million (202,000,000) US dollars** (« MCC Funds »), as well as a contribution from the Government of Benin of **two hundred and three million nine hundred and fifty one thousand four hundred and forty-six (\$203,951,446) US dollars**, aims to reduce poverty through economic growth in Benin.

The Government has designated MCA-Benin Regional to implement the Government's responsibilities under the Agreement and intends to apply parts of the funds to payments for contracts for Goods, Works and Services.

MCC has contracted Crown Agents UK to perform Interim Procurement Agent (IPA) Services on behalf of the Government of Benin, for the procurements to be funded by the Grant and Implementation Agreement.

The procurement of Goods, Works and Services funded by the program will be carried out in accordance with the procurement directives of the Millennium Challenge Corporation program as published on the MCC website: <u>http://www.mcc.gov</u>
