The United States of America, acting through the Millennium Challenge Corporation ("MCC") and the Government of Benin (the "Government"), have entered on **December 14, 2022,** into a grant agreement (« Compact ») to support regional economic integration. The Compact, covers an amount of **two hundred two million (US\$202,000,000) US Dollars** (« MCC Funds »), as well as a contribution from the Government of Benin of **two hundred and three million nine hundred and fifty-one thousand four hundred and forty-six (US\$203,951,446) US Dollars**, aiming at reducing poverty through economic growth in Benin.

The Government has designated MCA-Benin Regional to implement the Government's responsibilities under the Agreement and intends to apply part of the funds to payments for contracts for Goods, Works and Services.
