The United States of America, acting through the Millennium Challenge Corporation ("MCC"), and the Government of Benin (the "Government") signed on December 14, 2022 in Washington DC a grant agreement (the Compact) of two hundred and two million (202,000,000) US dollars ("MCC Funding"), with a contribution from the Government of Benin of two hundred and three million nine hundred and fifty-one thousand four hundred and forty-six (203,951,446) US dollars, aimed at promoting poverty reduction and economic growth in Benin through the financing of two (02) projects: the "Corridor Infrastructure (CI) Project" and the "Corridor Operations Effectiveness (COE) Project". The Government, acting through MCA-Benin Regional, intends to use a portion of the MCC grant for eligible payments under the Contracts for which this Request for Offer is issue.
- 2. MCA-Benin Regional now invites eligible Offerors to submit offers for the provision of health insurance services for its staff. Further information on the description of services is provided in Section V (Service Specifications of the Request for Offers (RFO).
- 3. The Service Provider will be selected through the Quality and Price Based Selection (QPBS) process, as described in the RFO and in accordance with the MCC Program Procurement Guidelines, available on the MCC website at www.mcc.gov/ppg. The selection process, as described, includes a review of the offeror's qualifications, past performance, and references prior to award of the Contract.
