1. The United States of America, acting through the Millennium Challenge Corporation ("MCC"), and the Government of Benin (the "Government") signed on December 14, 2022 in Washington DC a grant agreement (the Compact) amounting to **two hundred and two million (202,000,000) US dollars** ("MCC Funding"), with a contribution from the Government of Benin amounting to **two hundred and three million nine hundred and fifty-one thousand four hundred and forty-six (203,951,446) US dollars**, aimed at promoting poverty reduction and economic growth in Benin through the financing of two (02) projects: the "Corridor Infrastructure (CI) Project" and the "Corridor Operations Effectiveness (COE) Project". The Government, acting through MCA-Benin Regional, intends to use a portion of the MCC grant for eligible payments under the Contract for which this Request for Offers (« RFO ») is issued.
2. MCC's funding is appropriated by the U.S. Congress and obligated to the Compact upfront, with no incremental or partial funding. So, when a contract is signed with an Accountable Entity, money is already available to the Accountable Entity and, for most contracts, invoices are paid directly to Offerors by the US Treasury.
3. MCA-Benin Regional invites eligible Offerors to submit offers for the consultant services for the Renewal of life insurance for MCA- Benin Regional staff (« Offers»). Further information on these services is provided in the Terms of Reference at Section V of the Request for Offers (RFO).
4. The Consultant will be selected through the **Consultant Qualifications Selection (CQS)** process, as described in the evaluation procedure outlined in the RFO and in accordance with the MCC Accountable Entity Policy and Procurement Guidelines, available on the

MCC website at www.mcc.gov/ppg. The selection process, as described, includes a review of the Offeror's qualifications, past performance, and references prior to award of the Contract.
